Honorable Members of the Senate Finance Committee:

As the Governor of Isleta Pueblo of Isleta and on behalf of our students and community, I write to express our full support for Senate Bill 140, the Opportunity Scholarship Act. This legislation will support Native American students in seeking the career pathways that will provide family sustaining incomes and strengthen Tribal workforce and communities.

Governor Michelle Lujan Grisham's executive budget recommendation invests \$85.5 million for a comprehensive free college package, only one percent of the state budget. This crucial financial aid program will not only benefit recent high school graduates, but first-generation and non-traditional adult learners who may not be eligible for other scholarships. There are 11,408 Native American students enrolled in public higher education institutions and Tribal colleges in New Mexico. The Opportunity Scholarship Act would simplify the financial aid process and support up to 35,000 students, and in turn, thousands of Native American students across New Mexico.

The six-credit hour minimum will create greater access to state financial aid for students that are working, have family and cultural responsibilities, and will meet the diverse needs of New Mexico students. This credit hour reduction is critical to increasing access for students who previously had to decide between higher education and their personal circumstances and responsibilities. Now, they will no longer have to choose. This access is beneficial for our Native American students, whether they are enrolling immediately after high school or returning as an adult learner.

We applaud Governor Michelle Lujan Grisham for her leadership and forward-thinking decision to invest in New Mexico's Tribal students and communities, and we look forward to opening more doors for students to succeed.

Thank you for your ongoing commitment to New Mexico students. We appreciate your time and consideration of this important initiative affecting Native American students, families, and Tribal communities that can bring positive impacts for generations to come.
