- 3. RISE NM Presentation** – Joseph Leakados, Kathryn Zenoni and Kari Brandt presented updates and information on the RISE NM project or New Mexico Longitudinal Data System (NMLDS). The range of partners were covered: Technical, Agencies, and Policy. An overview of the mission and vision was provided. Project is currently in execution phase and expected implementation by June 30, 2023. Project is 82% complete. A breakdown of the data pipeline was provided. Data sources from agencies and their data systems was provided. Joseph covered the research process for the project. Project will not be done at June but will begin to display data to the public as it is an iterative process. There was discussion of DWS data and what is available.

- 4. Discuss Part-time Faculty Survey** – HED General Counsel pointed out that there is language specifically in statute of what must be included in HED Annual Report which includes faculty benefits and compensation. Some data of this may be in IPEDS but not everything like per-credit-hour pay rate. There will need to be further discussion on this before a survey is sent out.
