No, does not address all of the component skills under Critical thinking and communication "The proposal is focused on debates in the course, and the assessment is a description of the way the course will start and that there will be debates in the course - not an assessment that will be used in the course. The narrative states that critical thinking will "become a habit" because of the debate topics, but does not state the ways in which the component skills will be intentionally integrated into the course. There should be examples of problem setting, evidence acquisition, evidence evaluation, and reasoning/conclusion. " Personal social section- how will they learn ethics and intercultural understanding? My vote is actually "Maybe." In the Critical Thinking narrative, it's not clear how students learn to reason empirically. In the Personal and Social Responsibility narrative, it's not clear how students learn to reason interculturally and ethically. The assessment doesn't explicitly state how the three Essential Skills are evaluated. Overall, the narratives and the assessment emphasize debate

The narratives provided are heavy with sociological content. There needs to be a stronger connection to what students are doing in the course to practice the skills in this area. Narrative does not clearly describe components of essential skills. Narratives are too terse and do not document effectively how students demonstrate essential skills.
