A suggestion would be to organize each narrative more so around the essential skills and to show specifically how students work with the skill in question to learn it and then what sort of assessment is performed. Clearly this course requires students to use the skills in question. It's more that the application needs more specificity about how they are learned and assessed. Note also that typically the assignments turned in are the assignments themselves, and typically the assignments explicitly assess at least one of the essential skills.

#		Prelix	Number			The narratives are fairly general and non-specific in describing how students learn and demonstrate the specific component skills, and in fact many do not directly address the component skill in question. For example, in discussion of the component skill of evaluating and producing arguments in the Communications narrative, there should be a clear example of an assignment in which students are asked to produce an argument. The description given in the Critical Thinking narrative on Evidence Evaluation might actually work better for showing that students produce arguments for the class and that those arguments (critiques) are assessed. Note also that the uploaded assessment should be a specific assessment (assignment) for the class in which students are explicitly asked to work with one of the essential skills in that assignment—and so in which it is clear also that the essential skill is being assessed with that assignment.
						R&R recommended, to allow NMMI fine arts faculty to submit specific assessment rather than the statement of goals to be shared with NMCAC.
						There are not enough learning objectives for a 3 credit hour class. The students need more information of what the knowledge is they hope to gain in the class

The components of the rubric were mentioned but at times the explanations provided didn't demonstrate a clear sense of how the student activities related to the components.  On ethics section the statement of students responding "justly and fairly" is very vague.  Approved  Revise and Resubmit - On the fence with this one. One would guess that a student would have some art class before this to make a portfolio of work, therefore, the previous class should count as core not this.  It would have been helpful to have more specific examples of how some aspects of the essential skills are assessed—and note that typically the uploaded assessment should be an actual assignment that clearly evidences a request for students to demonstrate one or more of the essential skills and then an indication of how those skills will be assessed. The attached was a thoughtful description of the kinds of assessments that might occur.

						The narratives include specific references to the components of the rubric, but at times the explanations do not relate to what the students do that engage them in learning these components. For example, "Evidence Evaluation— Student's performance in this course will be assessed according to the following grading scale based on their completion of the course requirements."
